NATURAL HEALTH TRENDS ANNOUNCES THIRD QUARTER REVENUE ESTIMATE

DALLAS, TX, October 12, 2012 -- Natural Health Trends Corp. (OTCQB: NHTC) announced today that its estimated revenue for the quarter ended September 30, 2012 was \$9.3 million. The Company also estimates that its deferred revenue, consisting of unshipped product and unamortized enrollment fees, at September 30, 2012 was \$800,000, compared to \$1.6 million at June 30, 2012. In the third quarter of 2011, revenue was \$10.6 million, with deferred revenue of \$1.5 million at September 30, 2011 and \$2.7 million at June 30, 2011.

For the nine months ended September 30, 2012, estimated revenue is \$29.4 million, a 28% increase over the comparable period in the prior year. The various promotions and events that the Company conducted for its 10th Anniversary celebration that occurred during the third quarter of 2011 deferred revenue into the third quarter last year. A year-to-date comparison with the comparable period a year ago through September evens out such an effect.

These results are preliminary and have not been reviewed by the Company's independent accountants. Significant updates and revisions may be required before the release of our third quarter results in November.
